A **30 DAY WRITTEN** NOTIFICATION OF CANCELLATION IS REQUIRED FOR ALL MEMBERSHIP TERMINATIONS. ALL ACCRUED DUES AND OTHER CHARGES FOR WHICH THE MEMBER IS LIABLE ARE DUE UPON THE EFFECTIVE DATE OF RESIGNATION. ALL INITIATION FEES ARE NON-REFUNDABLE.

PAYMENT OF ACCOUNTS
